HOW AN ENGAGEMENT RUNS

- 01 Scope & estimate**
A real range in two minutes at pausestudios.org/quote — or send scope directly. Response within 24 hours.
- 02 Consultation & brief**
A short call confirms objectives, coverage priorities, deliverables, usage, and timing.
- 03 Agreement & hold**
Written agreement covering scope, rights, and terms. A 30% deposit holds the date. NDA in place first when required.
- 04 Coverage & delivery**
On-site candid-first coverage, then a private gallery sorted by use in 5-7 business days.
